Stretch Wrapper Warranty

NitechIPM warrants of all products and parts against defects in material and workmanship for a period of (3) years from date of shipment when given normal and proper usage as determined by NitechIPM upon examination, and when owned by the original user. Components purchased by NitechIPM as complete units and used as an integral part of NitechIPM'S equipment will be covered by the 3-year warranty. NitechIPM will repair or replace (F.O.B. original shipping point but not install) any part or parts of its manufacture which in its judgment, shall disclose defects in either material or workmanship. If requested by NitechIPM, parts for which a warranty claim is made are to be returned transportation prepaid by NitechIPM.

THREE YEAR MOTOR & GEARBOX WARRANTY

Your NitechIPM motor and gearbox are warranted 100% should they fail due to defects in materials or workmanship for a period of (3) years from the date of shipment, when given normal and proper usage as determined by the seller upon examination, and when owned by the original user. This warranty becomes void if the article claimed to be defective has been repaired or altered in any way, or if the unit has been subject to misuse, negligence or accident, or when the instructions for installing or operating have been disregarded. In regards to repair of warranted components, no component shall be repaired or warranted until authorization has been received from NitechIPM. After authorization has been given and a purchase order issued the component will be shipped UPS ground. If the end user or seller requires that the part be shipped other than ground service the freight charge will be their responsibility. A call tag will be sent to the seller or end user so the component is returned to NitechIPM free of charge to the seller or end user. In the case that the component is not returned to NitechIPM within 30 days the seller or end user will be charged for the component. Upon receiving the component NitechIPM will test the component for malfunctions or design issues and determine reason for failure or malfunction. After the component has been tested a statement will be issued explaining if the component will be covered under warranty.
